1. INTRODUCTION.

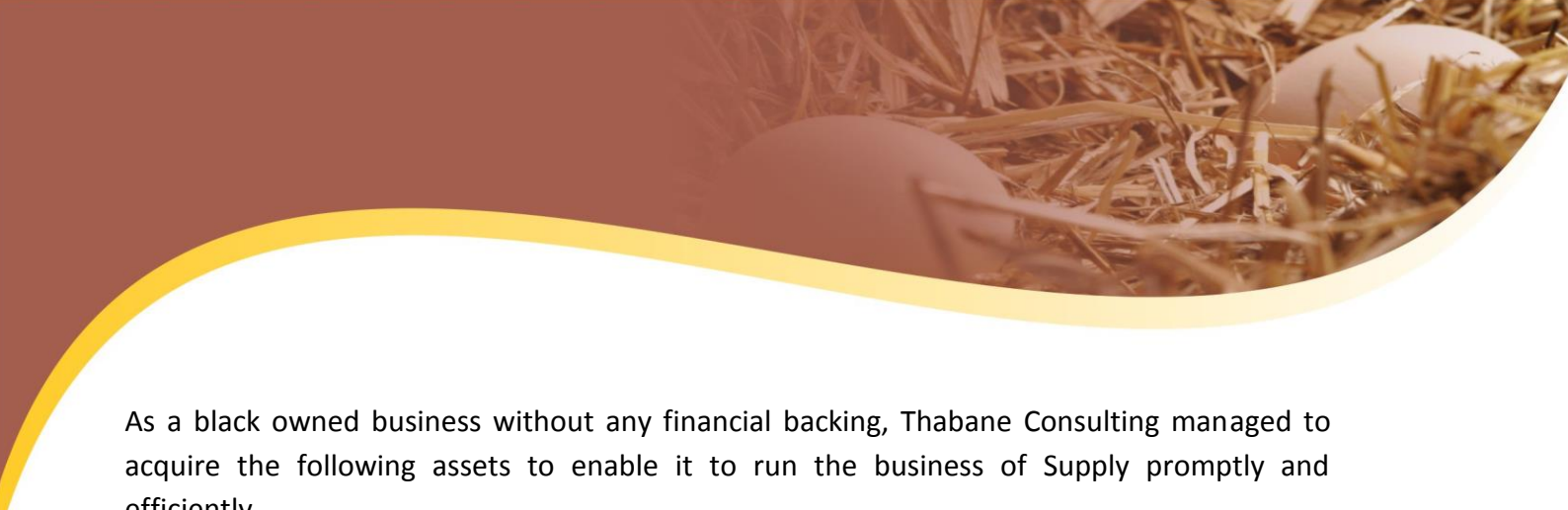

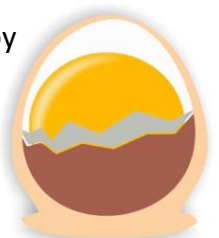

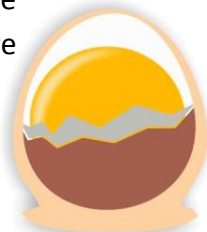
In 1996, he became a member of Tswasongu High School Governing Body.

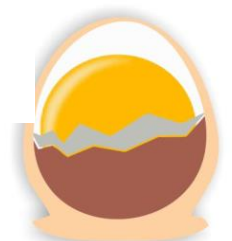

Chicken eggs weigh between 33 and 75 grams when laid, of which 90% is edible and the rest is the shell.

Every country has its own standards and regulations how eggs are sized and packed, and in South Africa these things are regulated by the agricultural product standards act, as amended from time to time:

- Jumbo eggs weigh more than 66 grams
- X-large eggs weigh more than 59 grams
- Large eggs weigh more than 51 grams
- Medium eggs weigh more than 43 grams
- Small eggs weigh more than 33 grams
